## OUR JOURNEY

The transformation of Down Home Ranch began with a new logo and mission statement, Empowering the lives of people with intellectual and developmental disabilities through Social, Educational, Residential and Vocational opportunities. Areas that we focused on in 2018 included increasing our presence in the community and providing more opportunities for the people we serve. As a result, we now serve 42 individuals through our residential program and 53 individuals through our day program. We maintain an 8 to 1 staffing ratio to ensure we can provide a high level of support. The Ranchers have the opportunity to spend a minimum of 30 hours a week in the community doing activities that they choose. Our plan for 2019 includes two additional homes and a new day program in the city of Elgin.

A key component of what we do focuses on person centered planning. The opportunities that we offer begin with a conversation with the individual. What are the things they want to achieve? What types of employment opportunities do they desire and where do they want to work? How do they define success? It is the role of the organization to create the opportunities and empower the individual to make the decisions.

This holistic collaboration is what defines Down Home Ranch. It is through person centered planning that we have supported people to become artists, laser operators, authors, entrepreneurs, horticulture specialists and so much more! They learn life skills, build self-esteem and earn at least minimum wage in their jobs. It is amazing to watch our residents grow in the roles they choose.

I am very happy with the progress we achieved in implementing the mission of Down Home Ranch in 2018. During this time, we were also improving the structure and culture of the organization. We reviewed and updated policies and procedures and set a liquidity target.

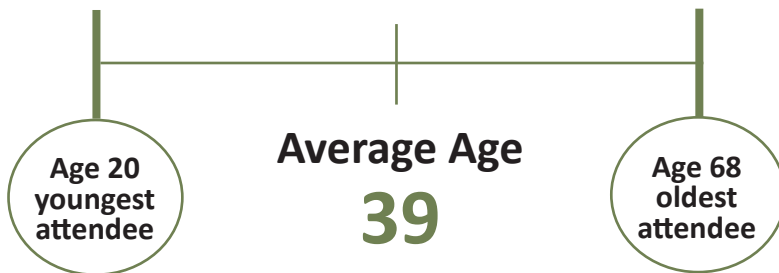

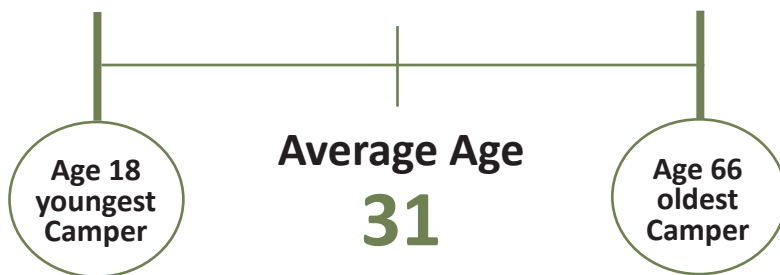

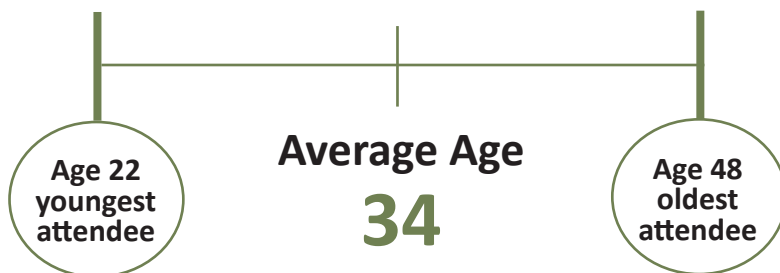

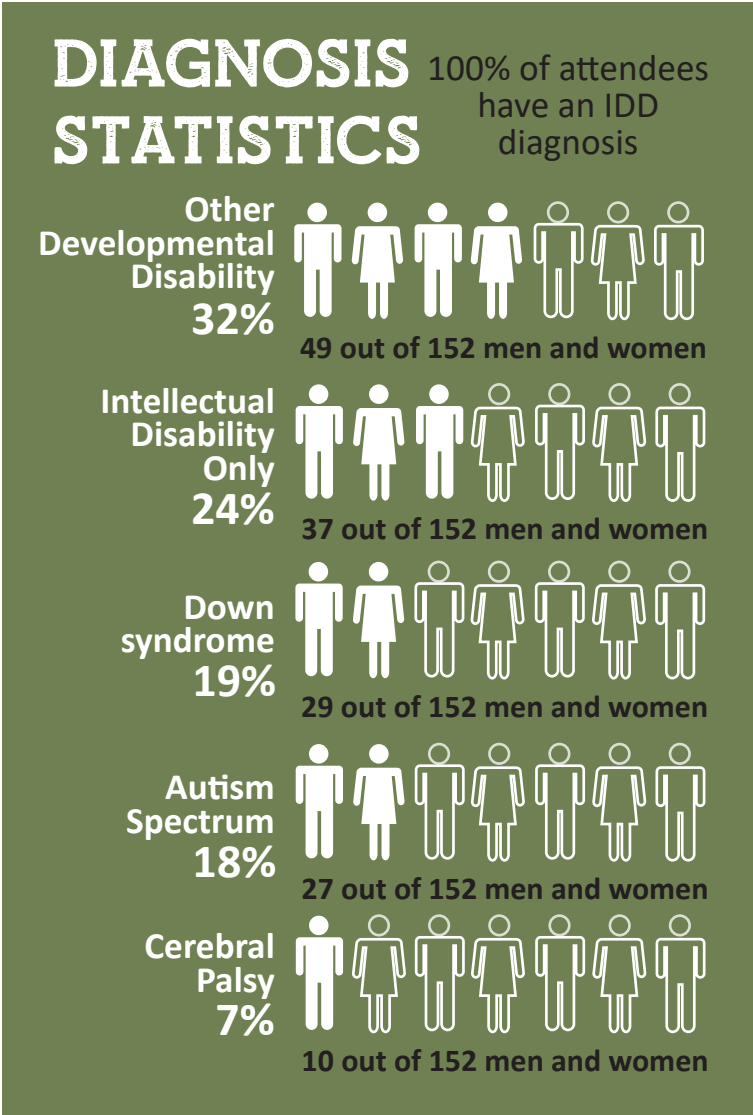


# HOW WE SERVE MORE

# SPECIAL EVENTS RECAP

All funds raised through these events go towards supplying the tools and opportunities to empower the lives of individuals with intellectual and developmental disabilities. The dollars raised provide crucial funding to allow Down Home Ranch to continue to positively impact the lives of current Ranchers, as well as funding to expand the current programs so that even more people are able to experience the life changing mission.



## Amplify Austin

The Ranch participated for the fifth time in this 24-hour day of giving in March. The 2018 campaign was successful with 30 individual fundraisers spreading the word of the DHR mission and the Ranchers we serve. In just ONE day, the Ranch raised over \$40,000 for the social, educational, residential and vocational opportunities we offer! Super special thank you to the 228 amazing donors who helped #AmpTheRanch and made this day a true success!

## Full Circle

In May, DHR partnered with five local farms to host our first ever farm to table event. From planting to watering, harvesting to food preparation, the Ranchers played a role in producing many portions of the meal. Around 70 individuals joined together for a fabulous six-course Cinco de Mayo themed meal. Private Chef, Scarlet Aguilar, wowed the crowd with delicious and beautiful courses. Overall, the event raised \$2,707 and truly showcased how our farming techniques empower the Ranchers in more ways than one.

## Swim Fest & Field Day

46 athletes made a lifetime of memories at the first annual Swim Fest & Field Day! The format changed in 2018 to include athletes from outside DHR, while also adding on four other sports. In total, six teams competed in swimming, football, track & field, golf and basketball. The competition was fierce, but the athletes, coaches, fans and volunteers displayed a positive attitude the entire day. In total, \$14,884 was raised for the social programs at Down Home Ranch!

In 2018 we celebrated another record-breaking Gala with the highest amount of funds raised in history! Around 350 people came together to celebrate the many successes of Down Home Ranch and together we raised a whopping \$127,042!

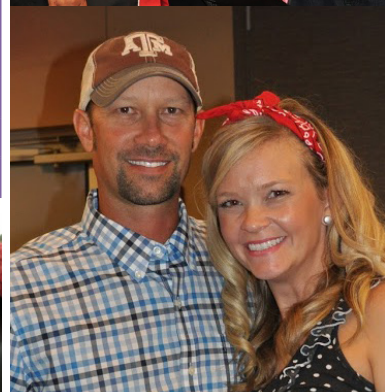
