



Interested Parents, Ranchers and Guardians,

Thank you for your interest in our residential programs. The following is a brief outline of the different options provided by Down Home Ranch and the process for consideration for each.

Intermediate Care Facility (ICF) (Located on-Ranch)

This is a federal-state program which pays all fees. We have 24 ICF slots on the Ranch proper, all in the Village in homes housing five or six Ranchers, each with a Resident Assistant who serves as mentor, advocate, and friend to the Ranchers under his or her care. We have three men's homes and two women's homes. Very rarely do we have a vacancy in these homes.

A prospective Rancher must be Medicaid-eligible in order to participate in ICF. We maintain an interest list in case a vacancy does occur. It is important to note, however, that we will fill the vacancy based on the very best fit for the house in question. We look for Ranchers who can both benefit from our community setting and contribute to it. Therefore, time on the interest list does not matter nearly as much as whether or not it's a good fit for the Rancher, for the home into which he or she will move, and for the Ranch as a whole.

Please fill out the form below completely and fax or email according to the instructions found at the end of the form. If there is an opening we will go through the list and select as many as three candidates for evaluation. We will ask those candidates to fill out an in-depth application form and schedule them for trial visits.

Supported Independent Living (SIL) (Located on-Ranch)

This option is available to Ranchers who meet the same criteria as other Ranchers and who are capable of living independently, either alone or in a cottage with another Rancher of the same gender. Staff support is available for coaching and training, but Ranchers in SIL must be able to meet the basic daily demands of self-care, grooming, rising on time and getting to work, etc.

The fee for SIL is \$3,500 per month, included all living costs and is subject to change. Ranchers in SIL are full members of the Ranch community and enjoy all privileges and programs.

The application process for SIL is similar in that appropriateness of placement is more important than longevity on a list, especially important considering that the Rancher in SIL will live with another Rancher without direct staff supervision.

Ranchers on SIL may apply for openings in the ICF program but would have to move into one of the group homes if accepted for such.

Home and Community Based Services (HCS) (Off-Ranch)

HCS is a federal-state program which pays most fees associated with participation. This is the program with the long wait list (up to 12 years or longer). A Rancher must be Medicaid-eligible in order to participate in this program. Prospective Ranchers must already have their HCS slot in order to apply. Interested parties should complete and submit a full application packet to determine whether the Rancher can fully benefit from this program.
