I UNDERSTAND AND ACKNOWLEDGE THAT AN AGRITOURISM ENTITY IS NOT LIABLE FOR ANY INJURY TO OR DEATH OF AN AGRITOURISM PARTICIPANT RESULTING FROM AGRITOURISM ACTIVITIES. I UNDERSTAND THAT I HAVE ACCEPTED ALL RISK OF INJURY, DEATH, PROPERTY DAMAGE, AND OTHER LOSS THAT MAY RESULT FROM AGRITOURISM ACTIVITIES. ON BEHALF OF MYSELF AND ANY PERSON FOR WHOM I SIGN THIS DOCUMENT, AND FOR ALL OUR RESPECTIVE HEIRS, ASSIGNS, FAMILY AND BENEFICIARIES, I HEREBY RELEASE, ACQUIT AND DISCHARGE DOWN HOME RANCH, INC. AND ALL ITS EMPLOYEES, OFFICERS, DIRECTORS, VOLUNTEERS AND ALL OTHER PERSONS AND ENTITIES WORKING WITH OR ASSISTING DOWN HOME RANCH, INC.
